Please choose one of the following options:

1. Providing Your Own Space

Each display area measures 10'x10'. No stakes allowed. Artists are responsible for providing their own display materials, including backdrops, tables, etc.

2. Tent Space Available

Each display area will measure 10'x10'. You will need to provide your own display materials, including backdrops, tables, etc. If you wish to reserve tent space, please indicate that on your application form. Spaces are assigned in the order that the registrations are received. Be prepared for wind.

3. Indoor Space

If there is inclement weather, Kennedy School will be available for indoor art sales with the same requirements as those listed in #2 above.

Weather:

Kennedy School will be used in case of inclement weather.

Entry Fees:

The entry fee is \$60.00 if you provide your own tent or \$80.00 if you use the tent we provide. Willmar Area Arts Council members can deduct \$10.00 from the entry fee. **Applications received after June 15, 2012 must pay \$20.00 late fee.**

Awards:

Awards of excellence accompanied by \$150.00 checks will be presented to three artists. The awards will be given on the basis of originality, craftsmanship, and overall quality of the work. The public will also vote for "People's Choice" award.

Sales Tax:

Exhibitors are responsible for collection and reporting Minnesota sales tax. A Minnesota Operator Certificate of Compliance Form will be sent to you before the festival and collected the day of the event. To register for a Minnesota Tax ID# call:

Deadline and Notification of Acceptance:

Jurying will be June 15. Notification of acceptance will be sent by July 1. Late applications will be considered on an individual basis and must pay \$20.00 late fee.

Eligibility:

Participation is open to all artists and fine craftspeople who will be exhibiting or selling work of original concept, design and execution. No imports, commercial jewelry, kits, molded ceramics or manufactured items will be accepted.

Application:

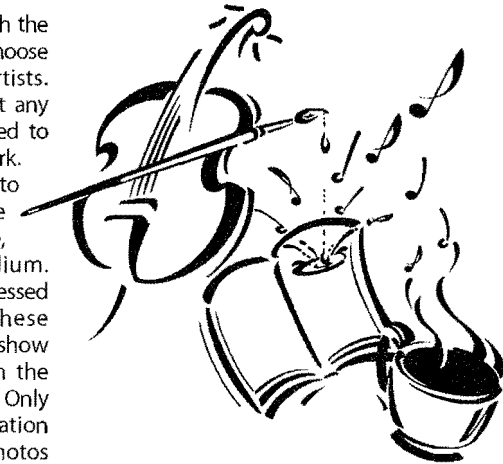
Every applicant will go through the jury process every year. We choose the best of all applying artists. We reserve the right to reject any application. All artists will need to send in 4 photos of your work. You can also email images to kmmorgan@en-tel.net. Please label these with your name, title, date, size, and medium. Enclose a stamped, self-addressed envelope if you want these returned. The work at the show needs to be consistent with the quality shown in the photos. Only items listed on your application and represented in your photos may be displayed and sold.

Cancellations:

There is no refund policy after being juried and accepted. Notice of cancellation is required.
